The Business Forum captivated with engaging perspectives from influential speakers and panelists


Sasi Nair, President, Northern India Steamer Agents Association & Senior Area General Manager – North India, CMA CGM Agencies (India) Pvt. Ltd. (Opening Remarks)

Mr Sasi Nair emphasised that North India is critical to India ex-im story, being a key driver of the country's export ambitions and a major consumption point for imports. North India is not just a market, it is a powerhouse of manufacturing, agriculture, services and entrepreneurship. He called for seamless connectivity, smart infrastructure, simplification of processes and policies, and partnership and trust across the value chain to further enhance the region's potential. While dedicated freight corridors, new expressways, multimodal logistics parks, port connectivity and port efficiency, and modern ICDs and CFSs are reshaping cargo and logistics, the next phase of growth will demand even more capacity, coordination and collaboration, he stressed. He lauded India's economic and ex-im trade growth last year despite the challenging global scenario, which clearly shows the resilience, determination, adaptability and diversified portfolio of the country's business. He expected growth to continue in 2026.



Sachin Bhanushali, Former Director & CEO, Gateway Distriparks Ltd & Advisor, FICCI Logistics Committee (Moderator delivering Theme Presentation)

Mr Sachin Bhanushali highlighted that North India has a pride of place in intermodal and international trade, enabled by its industry and vast hinterland serviced by a number of logistics facilities. He touched upon the importance of DFC connectivity to Nhava Sheva, which will allow the Mundra and Nhava Sheva port clusters to compete with each other for the benefit of the trade. The WDFC is unlikely to get congested, he said. The time taken for transportation should come down as a result so that every container connects to the vessel without getting rolled over. Besides, reduction in logistics cost will be a key driver for the competitiveness of the hinterland. On electronic integration of the complete process, he made the point that it has to ensure filing of information only once in a correct and verified manner, which then becomes available across the supply chain through the information flow, driven by integrated processes where machine learning, artificial intelligence and large-language models help in making the entire process much more humane and easily manageable.



Harpreet Singh Malhotra, CMD, Tiger Logistics (India) Ltd. (Keynote Address)

Mr Harpreet Singh Malhotra pointed out that the biggest challenge facing logistics companies in North India is that cargo is moving away from ICDs to the ports. Industries are moving to the ports. He attributed this to the cost factor. We have been talking of reducing the overall shipment time and bringing down logistics cost. But is that really happening, he asked. Are all the ICDs profitable? Is there overcapacity in the region? We are building capacity and infrastructure, but the important thing is to ensure that the cargo is held back in North India, he emphasised. He also called for a PLI scheme for the service sector, for logistics, opining that the government should look into some of the challenges plaguing the sector. He highlighted how China has been able to move away from the impact of the tariffs by shifting production to other countries. India is booming, no doubt, despite the challenges, and the focus is on growth. We all want to be part of that growth, he underscored.



Shobhit Bhatnagar, IRTS, Director (OP & BD), Dedicated Freight Corridor Corporation of India Limited (Guest of Honour)

Mr Shobhit Bhatnagar disclosed what the cargo and logistics trade had been wanting to hear for long, that the Western Dedicated Freight Corridor (WDFC), connecting Dadri to Jawaharlal Nehru Port Authority (JNPA), is likely to become fully operational up to JNPA by the end of February 2026. Track laying on the final stretch—from around Vaitarna to the port—has been completed, while signalling and electrical works are currently in progress. He noted that the completion of this section will enable double-stack container train operations till JNPA, along with improved long-haul rake movement. He also highlighted the corridor's 25-ton axle load capability, which provides an additional 11 tons per wagon and 500 tons per rake, thereby facilitating reduced logistics cost. The fully operational Eastern Dedicated Freight Corridor is seeing increased utilisation, he added.



Elroy Rodrigues, Head – India Container Sales (Landside), Adani Ports & Special Economic Zone Ltd. (Panelist)

Mr Elroy Rodrigues highlighted that Mundra Port is augmenting its terminal and rail infrastructure, which will enhance its capacity to 10 million TEUs. He also pointed out that the DFC has significantly reduced the transit time from the port to NCR, enabled double-stack connectivity, boosted volumes, brought down costs and ensured reliability. The number of double-stack trains has increased significantly. In a month, Mundra handles around 800 container trains, of which 75% are double-stack, both ways. The DFC has facilitated more efficiencies for the CTOs. There is better turnaround, loading of more containers, which has brought in efficiency and probably reduction in operating costs. Mundra's rail business is on the ascent and is projected to grow steadily, he added.



**Shridhar Subramaniam, Secretary,
Northern India Steamer Agents Association &
General Manager, KMTC India Pvt Ltd (Panelist)**

Mr Shridhar Subramaniam said that from the point of view of the shipping lines, the geopolitical situation has been the single biggest factor impacting volatility. Traditionally, the freight dynamics was in terms of the demand or capacity. But geopolitics has today entered the equation in a big way. For example, the Red Sea crisis has been one of the biggest factors influencing freight volatility in India. Carriers having to take a detour meant longer transit times, impacting vessel availability, fuel and operational cost, as well as schedule integrity. Trade between India and Europe has not really spiked that much, but the freight has moved. This is a key example of how the geopolitical scenario affects freight, he said. Geopolitics has also resulted in supply chains getting fragmented and becoming more regional. This is where initiatives like the India-Middle East-Europe Economic Corridor (IMEC) gain relevance, as countries are actively looking to de-risk the regional routes and over-dependence on a single corridor. It means new freight lanes will emerge and multimodal integration will now become more important, he added.



**Commander Pawan Kumar, Regional Manager -
Delhi NCR & Uttarakhand,
Central Warehousing Corporation (Panelist)**

Commander Pawan Kumar began by highlighting that CWC is today a multimodal logistics solutions provider with good warehousing space, rakes, wagons, and a vast network of open road transportation services. On the role of warehousing in the larger ecosystem of logistics, he said it is moving from the concept of storage to speed, a value enabler where the aim is to reduce the number of handlings, offer services like sorting and packaging in an evolving scenario where people are asking more for visibility and reliability. North India in particular is seeing tremendous growth in Grade A warehousing, where IT infrastructure/technology plays an integral part, with physical infrastructure more integrated and mapped into the digital ecosphere so that there is increased visibility, reliability and transparency for the customer. Regarding the poor quality of many warehouses, he made the point that India is a price-sensitive and fragmented market where there are small players who do not focus on modernisation, digitisation and standardisation. But things are improving, with customers demanding quality and world class facilities coming up.

**Parvinder Singh, MD,
Hans Infomatic Pvt. Ltd. (Panelist)**

Mr Parvinder Singh pointed out that while the core work of logistics is still being done with traditional software, the advent of AI is making the processes faster, simpler and less cumbersome for the logistics service provider and other stakeholders. We are now entering the Agentic AI era where the AI actually does the work, not just fetches the information. It gathers and crystallises the information, in a matter of seconds, round the clock and presents the results to logistics service providers as well as their customers. Errors will come down, it will be much faster, and the human resources freed will be re-deployed. One will not be making them redundant. They will have to be retrained so that they also understand what is AI, what it does, and move on to something new. But the question is will the trade pay for these technological benefits? India is a price-sensitive market where there is a reluctance to pay, the general preference being to get things for free, he added.



**Siddharth Rai Trikha, Director,
Samraat Indo Works Pvt. Ltd. (Panelist)**

Mr Siddharth Rai Trikha talked about the importance of being proficient in end-to-end logistics on a global scale. More than the ocean trade rates, shippers are concerned about the network a freight forwarder has overseas, the ability to execute shipments from end-to-end; pick-up in Egypt, delivery in Jakarta, pick-up in China, delivery on a specific zip code in the UK. On Indian service provides matching their MNC counterparts, he said that though the MNCs have the advantage of offices and networks all around the world, Indian companies are quite tenacious and enterprising and utilise their local, ground level knowledge well. They develop a deep and personal relationship with the customer, and are able to provide good services and keen competition to MNCs all around the world. Given the fast-paced advances taking place in technology, he called on business owners to keep upscaling, learn new skills and develop networks worldwide. Because that is what customers are now looking for.

**Dr Girish Kumar Tuteja,
Vice President & Global Head - Logistics,
Uflex Limited (Panelist)**

Dr Girish Kumar Tuteja said that given India's growing export ecosystem, with expanding FTAs, tighter global regulations and rising sustainability expectations, cargo and logistics stakeholders are judged on the basis of their reliability, speed and environmental responsibility. On flexible packaging, he pointed out that it is becoming a strategic component in India's export, ensuring compliance and also enhancing the brand's acceptance in the global market. Flexible packaging is lightweight, and are high-value films that have a longer shelf life and contribute to reduced costs for exporters. Regarding shippers' expectations from logistics service providers, he emphasised that shippers need end-to-end visibility of their cargo and a single platform to obtain all the information.


